INTRODUCTION

The Chiang Ching-kuo Foundation for International Scholarly Exchange (the Foundation) was established in 1989 in memory of the outstanding achievements of the late President of the Republic of China, Chiang Ching-kuo (1910-1988).

The Foundation's mission is to promote the study of Chinese culture and society, as well as enhance international scholarly exchange. Its principal work is to award grants and fellowships to institutions and individuals conducting Sinological and Taiwan-related research, thereby adding new life to Chinese cultural traditions while also assuming responsibility for the further development of human civilization.

Operational funds supporting the Foundation's activities derive from interest generated from an endowment donated by both the public and private sectors. As of June 1, 2021, the size of this endowment totaled NT\$3.62 billion.

The Foundation is governed by its Board of Directors (consisting of between 15 and 21 Board Members), as well as 3 Supervisors. Our central headquarters is located in Taipei, Taiwan, with a regional office near Washington D.C. in McLean, Virginia. In addition, the Foundation currently maintains four overseas centers: the Chiang Ching-kuo International Sinological Center at Charles University in Prague (CCK-ISC); the Chiang Ching-kuo Foundation Inter-University Center for Sinology at Harvard University (CCK-IUC); the Chinese University of Hong Kong – Chiang Ching-kuo Foundation Asia-Pacific Centre for Chinese Studies (CCK-APC); and the European Research Center on Contemporary Taiwan – A CCK Foundation Overseas Center at Eberhard Karls Universität Tübingen (CCKF-ERCCT). There are also review committees for the five regions covering the geographic scope of the Foundation's operations: Domestic, American, European, Asia-Pacific, and Developing. The members of these committees are distinguished scholars in the field of Chinese Studies, who are charged with screening and evaluating all applications in their respective regions.

The Year in Review

(July 2020 – June 2021)

Overview

The Chiang Ching-kuo Foundation for International Scholarly Exchange (hereafter referred to as the Foundation) is now entering its thirty-second year of operations. Established in January 1989 as the first Taiwan-based foundation to provide grants to scholars and institutions in Chinese Studies worldwide, the Foundation has funded more than 4,000 research projects in over 60 countries. These projects have resulted in the completion of over 1,000 scholarly articles and 1,000 books as well as nearly 1,000 doctoral dissertations. In addition, the Foundation has assisted 120 academic institutions in the United States and Europe in establishing over 140 positions in the fields of Sinology, Chinese Studies, and Taiwan Studies, clearly demonstrating its leading role in providing necessary resources for the development of these fields. In all, the Foundation's grants have totaled NT\$4,134,131,090 (US\$137,650,002).

From the very beginning, the government of the Republic of China (ROC) and donors from the private sector had the vision to establish the Foundation as an independent non-governmental scholarly agency. Under the leadership of its two late Chairmen, K. T. Li and Kuo-hua Yu, as well as former Chairmen Yih-yuan Li and Kaowen Mao, the Foundation has strived to adhere to the principle of awarding grants solely on the basis of academic merit. In 2003, Professor Yun-han Chu succeeded Professor Yih-yuan Li as President of the Foundation, working to promote cooperation with leading overseas academic institutions and international organizations.

Professor Yih-yuan Li was associated with the Chiang Ching-kuo Foundation since its establishment in 1989, serving four terms as President and then as Chairman for three terms. Under his leadership, the Foundation emerged as one of the most active and prestigious organizations dedicated to the promotion of Chinese Studies internationally. After Professor Li retired on June 5, 2010, Dr. Kao-wen Mao succeeded him as Chairman of the Foundation. After Chairman Mao's resignation, Dr. Fredrick F. Chien became the Foundation's newest Chairman in June 2019. Since becoming Chairman, Dr. Chien has followed the path of his predecessors, advancing the Foundation's mission in promoting international scholarly exchange while abiding by established principles and enhancing Taiwan's prominence in the global academic community. At the same time, he has taken initiatives to expand bilateral collaborations among scholars across the Taiwan Strait. The Foundation looks forward to the further fruition of its programs under Chairman Chien's leadership.

The Eleventh Board of Directors consists of the following twenty-one members: Morris Chang, Fredrick F. Chien, Yun-han Chu, Chin-shing Huang, Douglas Hsu, Ying-mao Kau, Ambrose King, William C. Kirby, Weifan Kuo, Lawrence Lau, James C. Liao, Chan Lien, Mon-chi Lio, Shou-chien Shih, James C. Y. Soong, Ovid J. L. Tzeng, Cher Wang, David Der-wei Wang, Ping Wang, Yueh-sheng Weng, and Pauline Yu. The current Board's term extends from June 1, 2019 to May 31, 2022.

The Board of Directors is the Foundation's most important decision-making body. In addition, In-jaw Lai, Fainan Perng, and Hau-min Rai serve as the Foundation's Supervisory Board. There is also a Finance Committee chosen by the Board of Directors; its members include Douglas Hsu, Lawrence Lau, and Ping Wang. The Supervisory Board and Finance Committee work to supervise the Foundation's endowment and strengthen

its financial operations by providing oversight in accordance with legal regulations and requirements, as well as striving to achieve the goals of prudent management and sustainable operations, thereby ensuring the Foundation's continued stability. The Foundation also operates five review committees to screen applications in the Domestic, American, European, Asia-Pacific, and Developing regions. During the 2020-2021 year, the Foundation's operations proceeded as follows:

I. Activities of the Board

1. Board of Directors Meetings

The Board of Directors met twice during the past fiscal year. On December 12, 2020, a total of 21 Board Members convened for the Fourth Meeting of the Eleventh Board. Chairman Fredrick F. Chien presided over the meeting, which was joined by Sophie Chou, Deputy Education Counselor from the Ministry of Education's Department of International and Cross-Strait Education. At the meeting, President Yun-han Chu reported on the Foundation's operations and financial situation, while David Der-wei Wang reported on the American Region's activities. In addition, the Board authorized the 2020-2021 annual budget, of which US\$2,600,230 was allocated for grant-making activities in the Foundation's five regions (Domestic, American, European, Asia-Pacific, and

Developing). The Board also approved the first round of grants as well as the following Special Projects: (1) Continued Support for the Small Grants Program and Graduate Student Paper Awards of the Association for Asian Studies (AAS); (2) Continued Cooperation with the Hou Family Foundation in Supporting the Fairbank Center Digital Scholarship Fund at Harvard University.

The Fifth Meeting of the Eleventh Board was held on May 22, 2021. Due to the COVID-19 pandemic, the meeting was held online, with 20 Board Members taking part (Mon-chi Lio and representatives of the Ministry of Education were unable to take part due to pressing official affairs). During the meeting, President Yun-han Chu provided a detailed update of the Foundation's operations, while Board Member Lawrence Lau summarized its finances and David Der-wei Wang reported on the American Region's activities. In addition, the Board approved 83 grant and fellowship applications with funding of US\$1,900,316.

2. Supervisory Board Meetings

The Third Meeting of the Supervisory Board of the Eleventh Board of Directors was held on December 21, 2020, with Board Members Fai-nan Perng and Hau-min Rai in attendance. Other participants in the meeting included Chairman Fredrick F. Chien, President Yun-han Chu, Vice-President Chun-i Chen and Finance Director

Ken Chiou, as well as Su-chin Hsu, Accountant from Baker Tilly Clock & Co. Section Chief Ling-ju Kuo and Assistant Research Fellow Cheng-tso Tu represented the Ministry of Education's Department of International and Cross-Strait Education. Board Member and Convener In-jaw Lai was unable to attend, so Hau-min Rai served as Convener in his stead. During the meeting, Chairman Chien explained that during the Board's first meeting, it has been decided that the three Supervisors would serve as Conveners on a rotating basis, with In-jaw Lai for the first year, Fai-nan Perng the second, and Hau-min Rai the third. However, since Fai-nan Perng stated that he would not be able to serve as Convener due to administrative ethics concerns, Hau-min Rai would assume that post for the second year. President Chu then reported on the Foundation's financial operations in 2020, while also presenting the results of the Fourth Meeting of the Eleventh Board of Directors, which had been held on December 12, 2020. These reports earned the Supervisory Board's full support, and were acknowledged by all meeting participants.

The Fourth Meeting, held on May 25, 2021, was attended by all three Supervisory Board Members, as well as Chairman Fredrick F. Chien, President Yun-han Chu, Vice-President Chun-i Chen, and Finance Director Maoliang Liu, as well as Auditor Su-chin Hsu, Section Chief Ling-ju Kuo and Assistant Research Fellow Cheng-tso Tu. President Chu began by presenting a detailed report of the Foundation's financial operations plus the results of the Fifth Meeting of the Eleventh Board of Directors, which had been held on May 22. Accountant Hsu then confirmed that she had audited the Foundation's balance sheets from December 31, 2020 and 2019, as well as statements of earnings, comprehensive income, changes in equity, and cash flows, for each of the two years

covering the period ending December 31, 2020, and related notes (containing principal accounting policies). She concluded with an unqualified opinion on the above financial statements being in conformity with "Regulations Governing Handling of Accounting and Drawing up of Financial Reports by National Education Foundations" and "Enterprise Accounting Standards" as well as related interpretations. Both reports were acknowledged by all meeting participants and gained their unanimous approval.

3. Finance Committee Meetings

The Third Meeting of the Finance Committee of the Eleventh Board of Directors was held on December 11, 2020. The Finance Committee consists of three Board Members (Ping Wang, Douglas Hsu, and Lawrence Lau), with Chairman Fredrick F. Chien serving as its Convener. President Yun-han Chu and Finance Director Ken Chiou also participated. After the meeting, the Committee reported to the Board of Directors that due to ever-increasing outlays for the Chi-Hai Cultural Park project, the gap between investable funds and net worth had increased. While adhering to relevant regulations, and keeping in mind the influence of real estate on asset allocation, new performance indicators should ensure that the proportion of risky assets should not exceed 60% of the Foundation's investable funds. Last year's investment performance was not up to par, the main reason being that sharp market fluctuations due to the COVID-19 pandemic raised concerns about another crash similar to 2008. Despite the fact that the Foundation missed its chance to catch the market's rebound, in light of the current high rate of market fluctuation, a conservative strategy would be in order, utilizing diversified investments

as well as a negative correlation between assets to ensure minimum risk. The Foundation has long adhered to a currency neutral principle, but this might need to be reevaluated due to depreciation of the U.S. dollar and global economic trends.

The Fourth Meeting, held on May 22, 2021, was also attended by all three Finance Committee Members, as well as Chairman Fredrick F. Chien, President Yun-han Chu, and Finance Director Mao-liang Liu. After the meeting, the Committee reported to the Board of Directors that the Foundation's asset allocation was in line with government rules and restrictions. Now that inflation is starting to appear, there may well be a need for conservative responses to increasing market risks in the future, with a potential hike in interest rates causing significant fluctuations in financial and currency markets. Moreover, the recent spike in COVID-19 cases in Taiwan has had a major impact on consumer markets, which in turn may exert a negative influence on stock and real estate markets. Therefore, it might be best to maintain a currency neutral policy, especially since some of the Foundation's expenses are in U.S. dollars and be used for long-term support of global activities.

II. Activities of the Foundation

1. Review Committees

In accordance with its charter, the Foundation has established review committees for each of its five regions of operation: Domestic, American, European, Asia-Pacific, and Developing Regions. The President of the Foundation chairs the review committee meetings, but takes no part in evaluating the applications. Service on these committees is three years per term, with roughly one third of the committee members rotating at the end of each term.

- (1) The Domestic Review Committee and the Asia-Pacific Review Committee were recently merged into a single joint Committee consisting of 14 distinguished scholars familiar with the Domestic and the Asia-Pacific regions' scholarly communities. The Committee is tasked with evaluating applications from universities and research institutes in the Domestic Region, as well as from countries including Australia, New Zealand, Japan, and Korea, plus some countries in Southeast Asia. In addition, the Committee reviews Doctoral Dissertation Fellowship applications from ROC graduate students based in the European, American and the Asia-Pacific regions. This year's meeting took place in Taipei on April 11, 2021.
- (2) The American Review Committee is composed of 18 distinguished scholars and professors from American academic institutions. In 2021, the Committee met online on March 28 to evaluate applications received from the American Region, as well as applications for American Doctoral Fellowships.
- (3) The European Review Committee is composed of 13 eminent scholars possessing an exceptional

understanding of European Sinology. The Committee met on April 10, 2021 in Taipei to evaluate applications from the European Region. In addition, the European Fellowship Review Committee met online on April 24 in order to review applications for European Doctoral Fellowships and Postdoctoral Research Fellowships.

(4) The Developing Regions Review Committee consists of 7 senior scholars from Europe, the United States, and Asia, who are charged with evaluating applications from countries in Eastern and Central Europe, Southeast Asia, South Asia, the Middle East, and Central Asia.

2. Grant Activities in the Five Regions

The Foundation's funding programs can be grouped into two broad categories: grants and fellowships. Grants provide assistance to academic institutions and individual professors, while fellowships subsidize doctoral students and postdoctoral researchers.

The Foundation received 156 grant applications in 2020-2021. Of these, 14 were from the Domestic Region, 101 from the American Region, 19 from the European Region, 19 from the Asia-Pacific Region, and 3 from the Developing Regions. The total amount requested was US\$5,727,219. Because of the time-sensitive nature of applications for conferences, publications, and travel grants, applications in those categories have two submission deadlines per year, while all other categories have one annual deadline. To ensure fair and objective treatment of each proposal, all applications are first evaluated by individual reviewers and then reassessed by the relevant regional review committees in a two-tier process. The review committees then rank the results of these

evaluations by priority before presenting them to the Board of Directors for final approval.

This year, the five review committees submitted 58 grant applications for the Board's approval. During the first round of applications, the Board approved 14 grants. One Publication Subsidy application was approved in the Domestic Region, with an award of US\$14,483 (NT\$420,000). A total of 10 Publication Subsidies were approved in the American Region, totaling US\$50,000. Two Publication Subsidies were awarded in the European Region, totaling US\$11,220 (10,200 Euros). For Developing Regions, 1 Research Grant proposal was approved, with an award of US\$12,000. The total budget for the first round of grants was US\$87,703.

During the second round of applications, the Board approved 44 grants. These included: 3 projects in the Domestic Region, with funding totaling US\$160,689 (NT\$4,660,000); 30 projects in the American Region, with a total budget of US\$451,881; 7

projects in the European Region for a total budget of US\$321,486 (292,260 Euros); and 4 projects in the Asia-Pacific Region, with budgets totaling US\$149,000. The total amount approved in the second round for all five regions was US\$1,083,056.

The Foundation also received 131 applications for dissertation and postdoctoral fellowships. Of these, 80 came from the American Region, and included applications from 71 Ph.D. candidates who were non-ROC citizens and 9 applicants who were ROC doctoral candidates. There were 48 applications from the European Region, including 39 European candidates (16 postdoctoral researchers and 23 Ph.D. students), as well as 9 ROC doctoral students in Europe. In addition, there were three doctoral dissertation applicants from the Asia-Pacific Region (Japan). The Board approved 23 applications from the American Region, including 20 fellowships for American doctoral candidates, and 3 for ROC doctoral candidates, with awards totaling US\$460,000. In Europe, the Board approved grants for 3 postdoctoral researchers, 9 European doctoral candidates, and 3 ROC doctoral candidates, with awards amounting to US\$337,260 (306,600 Euros). In the Asia-Pacific Region, the Board approved 1 ROC doctoral candidate for US\$20,000 (see Table 1; Figure 1).

Due to the continuing and serious impact of the COVID-19 pandemic on international travel, effective November 11, 2020, the Foundation placed a temporary freeze on all Conference Grant applications as well as Developing Regions Mobility Grant applications and Domestic Region Doctoral and Master's Students for Short-term Overseas

Research Grant applications. A decision on whether to reinstate these programs will be made at a future date.

The following grant and fellowship activities took place in the Foundation's five regions of operation:

(1) Domestic Region

The Foundation received 14 applications in 2020-2021 from 11 universities and research institutions in Taiwan. There were 12 Research Grants and 2 Publication Subsidies proposals, with requested funding totaling NT\$36,799,436 (US\$1,268,946). In the first round of competition, the Board of Directors approved 1 Publication Subsidy application for a total of NT\$420,000 (US\$14,483). In the second round, 2 Research Grants and 1 Publication Subsidy were approved for a total amount of NT\$4,660,000 (US\$160,689). The total amount of grants for the Domestic Region this year was NT\$5,080,000 (US\$175,172). If this region's Special Projects budget of NT\$2,410,000 (US\$83,103) is also included, the Foundation allocated 10.50% of its annual budget to the Domestic Region.

Two Research Grants in the Domestic Region this year were awarded, as follows: Professor Hsiang-ke Chao of the Department of Economics, National Tsing Hua University, with Professor Hsiao-ting Lin of the Hoover Institution, Stanford University for "Postwar Taiwan Revisited: State Making, Leadership Perceptions, and Conundrum for Trans-Pacific Alliance"; Professor Shu-kai Hsieh of the Graduate Institute of Linguistics, National Taiwan University, with Professor Harald Baayen of Eberhard Karls Universität Tübingen for "Computational Model on Lexical Semantic Changes in Chinese".

Two Publication Subsidies were awarded to *The Birth of Modernism in East Asia: Yokomitsu Riichi and Taiwan*, by Professor Huizhen Xie of the Department of Japanese, Wenzao Ursuline University of Languages, with Mr. Takashi Moriwaki of Hituzi Syobo Publishing Company; and *Frontiers of Memory in the Asia-Pacific: Difficult Heritage and Cross-border Politics of Postcolonial Nationalism*, by Professor Shu-mei Huang of the Graduate Institute of Building and Planning, National Taiwan University, with Professor Hyun Kyung Lee of Hankuk University of Foreign Studies and Professor Edward Vickers of Kyushu University.

(2) American Region

The Foundation received a total of 101 applications during the 2020-2021 grant cycle, including 23 Research Grants, 45 Scholar Grants, 2 Conference and Seminar Grants, and 31 Publication Subsidies. Additionally, there were a total of 80 fellowship applications from Ph.D. students. The American Review Committee recommended 63 proposals for a total amount of US\$961,881 to the Foundation's Board of Directors. The Foundation also awarded US\$150,500 in Special Project grants for a grand total of US\$1,112,381, which constituted 45.24% of its entire grant and fellowship budget.


Approved Research Grant applications covered many topics, including Professor Xiaolin Duan of North Carolina



of South Florida's "Public Assessments of the Police in Taiwan: Examining Procedural Justice with a Mixed Methods Approach"; Professor Chang Tan of Pennsylvania State University's "Fantastic Frames: Studio Photography of the 'Global Chinas'", etc.

The Foundation's American Review Committee also approved several Publication Subsidies from University of British Columbia Press, Brown University, University of California Press, Cambria Press, Cambridge University Press in New York, Cornell University Press, Columbia University Press, University of Minnesota Press, Syracuse University, and University of Washington Press.

(3) European Region

The Foundation received 19 applications from the European Region in 2020-2021, including 8 proposals from the United Kingdom, 3 from France, 2 each from Austria and Spain, and 1 each from Denmark, Germany, the Netherlands, and Slovenia. Applications included 10 Research Grant proposals, 2 Database Grant proposals, 2 Conference and Seminar Grant proposals, and 5 Publication Subsidy proposals. The total amount of funding requested was 949,173 Euros (US\$1,044,090). In the first round of competition, the Board approved 2 Publication Subsidies for a total of 10,200 Euros (US\$11,220). In the second round, 7 grants were approved for a total of 292,260 Euros (US\$321,486), including 4 Research Grants, 1 Database Grant, and 2 Publication Subsidies.

The four Research Grants awarded in the European Region this year included: "Translating Taiwan: A Semiotic Reading of Polyglot Sites, Memories, and Social Inclusion", by Professor Min-hsiu Liao of Heriot-Watt University; "Long-Term Archaeological Histories in Context: Heping Dao, Keelung, Taiwan", by Professor María Cruz Berrocal of University of Cantabria; "The Births of International Studies in China and Taiwan", by Professor Yih-jye Hwang of Leiden University; and "Navigation Practices in Asian Seas (16th to 19th Centuries)", by Professor Paola Calanca of École française d'Extrême-Orient.

One Database Grant was awarded to Professor Isabelle Cheng of University of Portsmouth, on behalf of the European Association of Taiwan Studies, for "Global Taiwan Studies Database: A Global Platform for Taiwan Studies".

Four Publication Subsidies was awarded to Mr. Joe Ng of Cambridge University Press, UK, for the publication of *Island Fantasia: Imagining Subjects on the Military Frontline between China and Taiwan*, by Professor Weiping Lin; to Professor Adeline Herrou of Centre National de la Recherche Scientifique for the publication of

The Feminine and the Religious: Texts Collected in Honor of Brigitte Baptandier, edited by Professors Gladys Chicharro, Stéphane Gros, Adeline Herrou and Aurélie Névot; to Ms. Vivian Constantinopoulos of Reaktion Books for the publication of Facing China: Portraits in Relation, by Professor Richard Vinograd; and to Professor Astrid Lipinsky for the publication of The Many Faces of Taiwan's Cultural Diplomacy: Marking the First Decade of VCTS, edited by Professors Astrid Lipinsky and Hsin-huang Michael Hsiao.

As in the American Region, the Foundation's European Region programs offer dissertation and postdoctoral fellowships for Ph.D. students and postdoctoral researchers. Proposals submitted to the Foundation included 23 Ph.D. Dissertation Fellowship applications and 16 Postdoctoral Fellowship applications. There were also 9 Dissertation Fellowship proposals from ROC students studying at European academic institutions. The Board of Directors approved 9 Ph.D. Dissertation Fellowships and 3 Postdoctoral Fellowships, with a total budget of 256,200 Euros (US\$281,820). In addition, 3 Dissertation Fellowships for ROC students in Europe were funded for a total of 50,400 Euros (US\$55,440), bringing the total fellowship amount to 306,600 Euros (US\$337,260).

In all, 756,760 Euros (US\$832,436) or 33.85% of the Foundation's grant budget (including 147,700 Euros (US\$162,470) for Special Projects) were allocated to the European Region in 2020-2021.

(4) Asia-Pacific Region

In 2020-2021, the Foundation received 19 applications from scholars in the Asia-Pacific Region, including 12 from Australia, 5 from Malaysia, and 1 each from Japan and New Zealand. There were 18 Research Grant proposals and 1 Conference and Seminar Grant proposal, with a total of US\$1,026,508 requested. In the first round of competition, none of the proposals was granted an award due to review results not being up to par. During the second round, the Board approved 4 Research Grant proposals, amounting to US\$149,000. In addition, 3 Dissertation Fellowships for ROC students in the Asia-Pacific Region were submitted, with the Board of Directors approving 1 such proposal with a total budget of US\$20,000. The total allocation for this region in 2020-2021 was US\$244,000 (including a Special Project grant for US\$75,000), or 9.92% of the Foundation's annual budget.

The four Research Grants awarded in the Asia-Pacific region this year included: "Ideology in Action: Educating Chinese Children in Law and Morality for the New Era", by Professor Delia Lin of University of Melbourne; "Chinatown: An International Comparative Atlas", by Professor Quentin Stevens of RMIT University; "The Rise of China and the Future of High Seas Governance", by Professor Nengye Liu of Macquarie University; and "Visual Propaganda in Mainland China", by Professor Jonathan Benney of Monash University.

(5) Developing Regions

The Foundation received 3 applications in 2020-2021 from scholars in Eastern Europe, including 2 from Poland and 1 from the Czech Republic, with requested funding of \$58,110. The Board of Directors approved 1 Research

Grant proposal for a total amount of \$12,000. The total allocation for this region in 2020-2021 was thus \$12,000, or 0.49% of the Foundation's annual budget.

One Research Grant was awarded to Professor Izabella Łabędzka of Adam Mickiewicz University in Poznań for "Contemporary Taiwanese Dance Theatre and Theatre of Movement (1973-2019)".

(6) Special Projects

A. Continued Support for the Small Grants Program and Graduate Student Paper Awards of the Association for Asian Studies (AAS)

Since its founding in 1941, the Association for Asian Studies (AAS) has developed into a leading scholarly association open to all persons interested in Asia and the study of its cultures. The AAS currently boasts a membership of approximately 7,000 scholars and experts encompassing all of Asia and related academic disciplines. Its Annual Conference, held every spring, attracts thousands of members to attend.

As part of its mission to promote international scholarly exchange, the Foundation has long maintained a special relationship with the AAS, especially in terms of helping to support its China and Inner Asia Council (CIAC) Small Grants program as well as its Annual Conference Graduate Student Paper Prize. The number of applicants for the Small Grants program dramatically increased during the past few years, with its funding benefitting nearly 500 scholars. Although each individual grant is relatively small, the impact of this program has been far greater than dollar amounts would suggest. In addition, the Foundation supports three annual Graduate Student Prizes for the best papers on China and Inner Asia, which are presented at the AAS' Annual Conference.

The year 2020 marked the 29th anniversary of cooperation between the Foundation and the AAS. Due to the outstanding success of these two programs, the Foundation decided to offer a new three-year grant.


B. Continued Cooperation with the Hou Family Foundation in Supporting the Fairbank Center Digital Scholarship Fund at Harvard University

In order to cultivate young talent, as well as enhance the international perspectives of outstanding graduate

students, in 2018, Universal Cement's Hou family contacted Harvard University Professor David Der-wei Wang, Director of the Chiang Ching-kuo Foundation Inter-University Center for Sinology (CCK-IUC), and asked him to help negotiate the establishment of a program to enhance intellectual exchanges among scholars working at Harvard and in Taiwan.

After extensive discussions, it was agreed that the Hou Family Foundation would provide support for a new Fairbank Center Digital Scholarship Fund, with priority given to Taiwan and Harvard University scholars engaged in activities including but not limited to the digitization, curation, and sharing of collections in Taiwan Studies and Chinese Studies, as well as support for postdoctoral fellows, faculty, and students engaging in these activities (including travel and meeting expenses).

Highly impressed by the Hou Family Foundation's outpouring of support for this new program, and taking

into consideration Harvard University's leading position in promoting digitization programs in the fields of Taiwan Studies and Chinese Studies, the Foundation decided to continue its support of the Fairbank Center Digital Scholarship Fund, joining the Hou Family Foundation in providing an additional three years of funding.

3. Overseas Sinological and Taiwan Studies Centers

(1) The Chiang Ching-kuo Foundation International Sinological Center at Charles University (CCK-ISC)

In 2020-2021, the Center conducted its activities in accordance with the three-year framework program approved by the Foundation in 2017. This year is the third year of the seventh cycle of the Center's operations, which commenced in 1997.

The Center continued its traditional collaboration with East European universities, with students and young scholars from the region taking part in programs and activities organized and sponsored by the Center. Due to the impact of the COVID-19 pandemic, a majority of the Center's activities had to be cancelled. The following activities were undertaken:

A. Small Research Projects

The Center supported 3 small research grants: a. František Reismüller, who held a post-doc position at Charles University (not supported from CCKF), prepared an annotated Czech translation of Prof. Kang-i Sun Chang's memoirs (*Journey Through White Terror: A Daughter's Memoir*) and added an extensive essay on Taiwan history. b. Michaela Pejčochová, curator of the Chinese Collection in the National Gallery in Prague, researched the early history of Chinese art collecting in the Czech Republic, with a special focus on the National Gallery. Both research grants will result in book publications in 2021. c. The Center also granted support to Kateřina Gajdošová's finalizing her dissertation on early Chinese Philosophy.

B. Visiting Professors

One on-line course was prepared: Dr. Emina Popović (Berlin), "Contemporary Chinese Politics". This course was held on a weekly basis during the semester and was transdisciplinary in nature, attended by students of Sinology and the social sciences.

C. Library Acquisition

The Center continued book acquisition for its library as in previous years. Apart from printed material (mostly in English and Chinese languages), inter-library loan services were also supported (mainly for the benefit of students writing their research papers and theses). For this purpose, the Center continues to enjoy the privilege of a special partnership with the Chinese Department of the German State Library in Berlin.

(2) The Chiang Ching-kuo Foundation Inter-University Center for Sinology (CCK-IUC)

The Chiang Ching-kuo Foundation Inter-University Center for Sinology (CCK-IUC) has been actively engaged in the organization and coordination of various conferences, workshops, and special events. From 2020 to 2021, many of the Center's activities were conducted online because of the COVID-19 pandemic, including international conferences, workshops, and jointly organized scholarly events. (3) The Chiang Ching-kuo Foundation Asia-Pacific Centre for Chinese Studies at The Chinese University of Hong Kong (CCK-APC)

Since its founding in 2005, the Chiang Ching-kuo Foundation Asia-Pacific Centre for Chinese Studies at The Chinese

University of Hong Kong (CCK-APC) has devoted unstinting efforts to promoting scholarly exchanges among Taiwanese, Chinese, and Hong Kong scholars. The Centre's future goals center on two main endeavors: the Annual Graduate Seminar on China and the Young Scholars' Forum in Chinese Studies. The Graduate Seminar takes place every January, with between 50-60 faculty and graduate students taking part. The Young Scholars' Forum is open to 25 advanced graduate students from throughout Asia. Both events allow the next generation of academic elites to present their recent results.

2020-2021 Annual Report

A. The Sixteenth Graduate Seminar on Modern and Contemporary China (GSOC 2022)

GSOC 2022 is scheduled to take place on January 6-7, 2022, with 25 graduate students planning to take part. The Seminar is conceived of as a prime opportunity for younger scholars to learn from each other and from the experienced scholars who also take part, as well as broaden their visions and build up their academic networks.

The Centre for Chinese Studies will organize and oversee GSOC 2022 with the support from the CCK-APC and Institute of Chinese Studies (ICS). The Seminar's theme is "Land in China, 1900-2022". The Seminar welcomes paper proposals on subjects from across the spectrum of environmental, economic, political, legal, social, ideological and cultural approaches to examining changes affecting land in China during the last century until today. All disciplines and theoretical frameworks will be considered, so long as the papers are based on original, empirical research.

B. Young Scholars' Forum in Chinese Studies 2021

The Seventh Young Scholars' Forum in Chinese Studies, co-organized by the CCK-APC and ICS was held on May 27-28, 2021. A call for paper proposals on the theme "Intellectual Networks and Knowledge Production: Remapping Chinese Studies" was issued in October 2019, with Ph.D. students (after completing qualifying examination) or Ph.D. graduates with less than five years of work experience invited to present their recent research results on any aspect of Chinese Studies, focusing on but not limited to the disciplines of history, literature, religion, art and intellectual history.


A total of 184 applications were received: 20 from Hong Kong, 49 from China, 7 from Australia, 35 from North and South America, 46 from Europe, and 27 from other Asian countries and areas. The Forum was originally

scheduled to be held on May 28-30, 2020, but its postponement resulted in the withdrawal of 5 out of the 33 selected applicants, so there will be 28 young scholars participating in the Forum, including 13 from China, 3 from the U.S., 3 from Europe, 3 from other countries in Asia and 6 from Hong Kong.

C. Young Scholars Visiting Scheme

The Young Scholars Visiting Scheme was launched in 2018 to support travel to CUHK by young scholars doing research in Chinese Studies. During the 2019-2020 term, four young scholars confirmed their intention to visit. Because of the COVID-19 pandemic, one scholar, Dr. Qiaomei Tang from Grinnell College, succeeded in visiting CUHK.

The Young Scholars Visiting Scheme 2021 selected 5 applicants in

December 2020, including 2 from the U.S., 1 from the UK, 1 from China and 1 from Israel:

- b. Dr. Hye-shim Yi (Kent State University, U.S.)
- c. Dr. Ronald C. Po (London School of Economics and Political Science, UK)

Dr. Hye-shim Yi and Dr. Nagatomi Hirayama plan to visit CUHK in the autumn semester 2021; the visiting periods for the remaining selected young scholars have yet to be confirmed.

D. APC Visiting Scholar Scheme 2021-2022

The APC Visiting Scholar Scheme aims at inviting scholars in the field of Chinese Studies to visit and conduct independent research at CUHK. Visiting scholars supported by this scheme are expected to deliver lecture(s) during their stays, and are also expected to publish a book manuscript/chapters acknowledging the support of this program.

The COVID-19 global pandemic and travel restrictions have made it very difficult for overseas scholars to visit CUHK. Therefore, this year the CCK-APC invited a renowned local scholar, Professor Ming Chiu Lai, Chair and Professor of the Department of History at CUHK who retired this July, to conduct research in Chinese Studies from August 2021 to July 2022. Prof. Lai's research topic is "An Analysis of the Social Life and Local Community of the Linxiang County during Eastern Han Period: Evidence of the Wooden Manuscripts from Wuyi Square of the Changsha Province". The CCK-APC would provide a lump sum of HK\$50,000 as a publication subsidy, as well as office space during his visit.

(4) European Research Center on Contemporary Taiwan - A CCK Foundation Overseas Center (CCKF-ERCCT) at Eberhard Karls Universität Tübingen

Established in July 2014, the CCKF-ERCCT at Eberhard Karls Universität Tübingen is the Foundation's newest overseas Center. During the past year, it has sponsored the following events:

A. Taiyupian 2.0: Guest Lecture on Taiwan Cinema and Online Film Screening

On Wednesday, June 24, 2020, the ERCCT, in cooperation with China Centrum Tübingen (CCT), hosted an online talk and discussion with Chris Berry, professor of film studies at King's College London. Entitled "Modernity, Gender, Sexuality: Social Values in Taiyupian", the talk referred to two Taiwanese movies that are part of the project on Taiyupian 臺語片 entitled "Taiwan's Lost Commercial Cinema" by film scholars Prof. Berry and Dr. Ming-yeh Rawnsley. One film was "Foolish Bride, Naive Bridegroom" 三八新娘憨女婿, a

comedy from 1967 by Xin Qi, and the second was "Like Father, Like Daughter" 前世情人的情人, a modern sequel to the first. Both films were made available to registered users for online viewing four days prior to the event.

B. ERCCT Taiwan Documentary Film Festival 2020

The CCKF-ERCCT celebrated Taiwan Documentary Film Festival 2020 online from November 13 to 22, with a focus on Taiwan's Indigenous Peoples and their film-making activities.

Upon free-of-charge registration, participants were able to stream four valuable documentary films during the Festival period, two of which are works by this year's guest director and Atayal social activist Pilin Yapu 比令亞 布.

The Festival started with an introductory talk and Q&A with National Dung Hwa University anthropologist Prof. Kerim Friedman on Monday, November 16, 2020, entitled "Space, Time, and Indigeneity in Contemporary Taiwanese Documentary Film". Guest Director Pilin Yabu then joined on Friday, November 20, for a discussion of his work. The Festival attracted over a hundred viewers who registered for the event.

C. The Taiwan Colloquium Series Online

In order to adapt to the situation of having to work without visitors staying at the Center, the CCKF-ERCCT set up its Taiwan Colloquium Series as a combination of online guest lectures and project presentations throughout the winter semester 2020/2021.

During the 2020-2021 term, six scholars presented their research online:

- a. Prof. Chieh Hsu (Global Asia Research Center, National Taiwan University), spoke about "The Path to an Occupation: The (Early) Experiences of Highly Skilled Taiwanese and Chinese 'Wives' in Germany" on January 11, 2021.
- b. Prof. Po-han Lee (Institute of Health Policy Management, National Taiwan University), presented "Solidarity with Whom? Repositioning Taiwan beyond the WHO's Epidemiological (Inter-)Nationalism" on January 18.
- c. Prof. Min-xu Zhan (Graduate Institute of Taiwan Literature and Transnational Cultural Studies, National Chung Hsing University), gave a talk on "Taiwan Literature from a Southern Perspective" on February 1.

- d. Dr. Beatrice Zani (CCKF-ERCCT Associate Fellow) talked about "Women Migrants in Southern China and in Taiwan. Mobilities, Digital Economies, and Emotions" on February 8.
- e. Dr. Gwennaël Gaffric (Department of Chinese Studies, Jean Moulin Lyon 3 University), spoke about "Taiwan Literature in the Era of the Anthropocene" on February 15.
- f. Prof. Hsun-hui Tseng (Department of Taiwan Literature, National Cheng Kung University), addressed the audience on the topic of "Motherhood and Moral Economy: The Art of Negotiation of Marriage Migrants Engaged in the Sex Entertainment Industry in Taiwan" on February 22.

The Taiwan Colloquium Series was well received by the audience. Its extraordinary quality inspired us to continue organizing digital lectures even after the COVID-19 crisis has concluded as a corollary to our usual offline-formats, as more people can be reached and more scholars not able to conduct long-distance travel can be included.

D. Young Scholars Workshop

On July 9-10, 2021, the CCKF-ERCCT hosted a smaller version of the Young Scholars Workshop online. Four young scholars presented their research projects. Apart from these presentations, the program featured a session on publication strategies in Western social science journals for young Taiwan scholars, and a public roundtable with established scholars debating the question "Is Taiwanese Society Ready to Face a Belligerent China"?

III. General Affairs

1. Progress on the Ching-kuo Chi-Hai Cultural Park

During the past few years, the Foundation and the China Christian Faith, Hope, Love Foundation have been working together on a monumental project, establishing the Ching-kuo Chi-Hai Cultural Park and the Chiang Ching-kuo Presidential Library, a joint effort that represents their shared commitment to preserve and enhance Taiwan's cultural heritage. These projects are dedicated to the memory of Former President Chiang Ching-kuo, who made a major impact on modern Taiwanese history, especially democratization and economic development. The beneficiaries of this project will include tourists and members of the general public who choose to visit, as well as academic organizations and scholars in the field of Chinese Studies.

In June 2012, the Taipei City Government began accepting proposals for OT (Operate Transfer) and BOT (Build-Operate-Transfer) projects for the Ching-kuo Chi-Hai Cultural Park. The Foundation submitted its proposal on July 16, and, following two years of due diligence during a rigorous review process, an agreement was signed with the Taipei City Government on April 11, 2014. According to the terms of the agreement, the Foundation has the right to operate the Cultural Park and the Library for a period of 50 years, and priority for extending it an additional 20 years. On February 25, 2016, the urban planning review process was successfully completed, with

a building license issued on October 4 and an application submitted for beginning construction on March 22, 2017. Due to various factors beyond the Foundation's control, work on the construction project suffered a series of delays. In the end, the parties agreed on an extension to May 31, 2021.

The Foundation and the China Christian Faith, Hope, Love Foundation have made the following progress during the past year.

(1) Elegant Interior Design

Architect Jen-lu Yao had originally been in charge of interior design for the Park's main buildings and Visitor Center, but on August 21, 2020 submitted a letter stating that, for a variety of reasons, he would not be able to continue in his capacity. Four days later, on August 25, Foundation President Yun-han Chu paid a visit to Ruentex Group Chairman Samuel Yin. Chairman Yin offered the services of Ruentex Interior Design, Ltd. for this project, and generously made an in-kind donation to support these efforts. On October 15, President Chu took Chairman Yin and other Ruentex Interior Design officers on a tour of the Park to take stock of the progress that had been made.

Ruentex Interior Design, Ltd. has extensive experience in this field, with renowned projects including interior design for National Chengchi University's Dah Hsian Seetoo Library, the Tsai Yuan-pei Memorial Hall, Dharma Drum Mountain, etc. Its skills have earned frequent recognition worldwide, including Italy's A'Design Interior Decoration Award (2020), the Gold Medal, Silver Medal, and Excellence Award for the 2019 Taiwan Good Design Award, etc.

A number of other companies also contributed to interior design project, including Chieh-hsun Industrial

Company, Ltd. (multimedia), Delta Electronics (internet and wireless networks), the Aurora Group (office furniture), UB Union Technologies (ticket vending machines), Nobel Electronics (machines for the parking garage), etc. On June 18, 2021, the Park obtained a certificate of compliance with interior design standards.

(2) Plans for the Exhibition Halls

One main goal of the Ching-kuo Chi-Hai Cultural Park and the Chiang Ching-kuo Presidential Library projects is for its exhibition halls to dynamically embody the spirit of Former President Chiang Ching-kuo. Apart from helping visitors learn about the details of his life, this space should also provide a new and enlivening experience. In order to achieve these aims, the Foundation has entrusted the design and planning processes to Professor Wei-gong Liou and Mr. Sean Hu, who took part in weekly meetings with Foundation Vice-Presidents Chun-i Chen and Siao-chen Hu, as well as Chief Secretary Tsui-yin Sung. The contents of the Park's exhibitions are as follows:

A. Exhibitions in the Anteroom of the Chi-Hai Residence

The Anteroom of the Chi-Hai Residence is where visitors will wait before starting their tours. Its exhibition area includes information on tours, guided tours, photography, etc. This area also tells the story of this building and its environs, which are now part of the Ching-kuo Chi-Hai Cultural Park, including its ecology, flora, and fauna as well as their change over time. In addition, there is a multimedia area for handicapped people unable to take part in a tour of the site.

B. The First Exhibition Hall

The First Exhibition Hall contains "The Driving Force Behind Taiwan's Modernization", which is dedicated to Former President Chiang Ching-kuo's life and career. This exhibition features handwritten manuscripts, photographs, furniture,

and other historical artifacts. The contents of this exhibition will help viewers better appreciate Former President Chiang's warm and caring personality, his steadfast commitment to Taiwan's development and democratization, plus the tenderness of his family life. The exhibition consists of six units, as follows:

- a. Major Events in the Life and Times of Chiang Ching-kuo: Uses written texts and images to display different stages of Former President Chiang Ching-kuo's career. Its touch screens allow visitors to fully appreciate the unique features of many major domestic and international events.
- b. Chiang Ching-kuo and "The Unity of Knowledge and Practice": Draws on Wang Yangming's philosophy of "The Unity of Knowledge and Practice" to display Former President Chiang's love for his people and devotion to his family. His career featured many visits to the common people, with whom he built a caring relationship as they worked together to overcome hard times.
- c. Chiang Ching-kuo's Wisdom in Leadership at Critical Times: From his youth up to his assumption of key leadership positions, Former President Chiang displayed great wisdom during times of crises, including Taiwan's departure from the U.N., breaking of diplomatic relations with the United States, Meilidao Incident, and many other historic events.
- d. Epoch-making Achievements Under Chiang Ching-kuo's Leadership: Draws on digital interactive features to showcase Former President Chiang's legacy, including developing the Southern Jiangxi Province Special Administrative Region, enacting administrative reform, launching the Ten Infrastructure Projects, promoting the growth of Taiwan's high-tech industry, creating Taiwan's economic miracle, etc. This exhibition will help viewers get a better sense of how life in Taiwan has improved during the modern era.

- e. Chiang Ching-kuo's Smile: During his first 4 years as President, Chiang visited the countryside 197 times, spending 155 days with the people. Photographs show the warmth of his buoyant smile, while visitors can also listen to audio recordings and watch film clips of these events.
- f. Faina's Resolve: The shy and retiring Faina Chiang Fang-liang, Former President Chiang's devoted spouse, rarely made public appearances, but her support was a vital source of strength to him. By viewing family clothing, furniture, and photographs, visitors can get a better sense of the simple yet caring nature of their family life.

C. The Second Exhibition Hall

The theme of the Second Exhibition Hall is "Contemplating the Passage of Time", and draws on both digital displays plus historical artifacts such as Former President Chiang's calligraphy and paintings, diary, as well as the memories of his staff, to present a holistic view of his inner worlds. By using immersive exhibition methods, the Hall brings viewers back to the atmosphere of the time period covering the 1960s to 1980s.

Former President Chiang was a fine calligrapher, but he also found the time to study painting under the tutelage of Kao Yi-hung. This exhibition features some of his finest artworks, including "A Tree Rising to the Sky", "Bamboo", and "A Quiet and Easy Disposition". There is also painting that Kao gifted to Chiang on his 60th birthday as a token of their friendship, entitled "The Eagle Spreads Its Wings".

Former President Chiang Ching-kuo's diary is a veritable chronicle of his life and career, shedding light on his joys, sorrows, and reflections. This exhibition features passages from the diary dating to the 1950s and 1960s, which demonstrate his achievements in Taiwan's economic and commercial development, foreign policy, and internal affairs, plus his devotion to his father and his family.

The Second Exhibition Hall also contains a space for audio-visual media featuring broadcasts of interviews with Former President Chiang's staff. By sitting in a quiet space and listening to these reminiscences, visitors can get a different sense of the meaning of his life and career.

The contents of these exhibitions will be based on an online database of artifacts linked to the life and career of Former President Chiang Ching-kuo. In addition, the Foundation has worked with the Institute of Modern History, Academia Sinica, to perpetuate scholarly research on President Chiang's contributions, most notably the Chronicle of Major Events in the Life of Chiang Ching-kuo. The Foundation also joined forces with the Institute of Modern History to undertake an oral history research project featuring interviews with former members of President Chiang's personal staff. Other projects involve the Foundation working with Academia Historica, the KMT Archives, and the Hoover Institution at Stanford University to collect additional materials, as well as cooperating with Taiwan Public Television Service, the United Daily News, the Military News Agency and other organizations to locate and obtain permission to use photographic, audio-visual, musical, and film materials for future exhibitions.

(3) Progress on Other Park Construction Projects

From July to October 2020, the Foundation worked with the China Christian Faith, Hope, Love Foundation and Li Jin Engineering Co. Ltd. to complete final acceptance checks on the Library and the Visitor Center, following which responsibility for interior design work was handed over to the Ruentex Group. During this time period, the Foundation started to invite Board of Directors Members to visit the site and offer suggestions for its enhancement. On July 31, 2020, President Yun-han Chu accompanied Board Member James C. Y. Soong on a tour of the site, and did the same for Board Members Chin-shing Huang, David Der-wei Wang, and Shou-chien Shih on August 6. On December 1, Vice-President Chun-i Chen led a tour for Board Members Yueh-sheng Weng and Wei-fan Kuo, as well as Board Member Ying-mao Kau and his wife. One week later, on December 8, he accompanied Board Members Douglas Hsu and Ovid J. L. Tzeng on their own tour.

In terms of public art, on September 28, 2020, Vice-President Chun-i Chen, Chief Secretary Tsui-yin Sung, China Christian Faith, Hope, Love Foundation Managing Director Tseng-chieh Hsu, and architect Philip Fei conducted an inspection to mark 70% of that project's completion, with final acceptance checks completed on April 15, 2021. Landscaping work was completed by mid-May. In addition, there were donations of solar panels and a smart surveillance system, as well as completion of a weak current system in late May. The Park's certificate of compliance with interior design standards was obtained on June 18, while its official seal for green architecture should be ready by late December.

Work on the Chi-Hai Residence featured registration for a fire safety inspection on May 1, with the inspection being successfully completed on May 6. On May 31, the Taipei City Government granted permission for the Residence to be used as a historical monument. Other projects for the Residence included repairs to the walls and floors, cleaning the air conditioning system, installation of new lighting, painting, etc. Work on the Residence's Anteroom was completed in late April, including the gardens and flag-raising platform.

(4) Plans for the Park's Operations

The Foundation and the China Christian Faith, Hope, Love Foundation are joining together to manage the Park's operations, with the Foundation being responsible for the Chi-Hai Residence, Exhibition Halls, Chiang Chingkuo Presidential Library and Multimedia Meeting Rooms; and the China Christian Faith, Hope, Love Foundation taking charge of the Gift Shop on the Visitor Center's first floor and Restaurant on its second floor, while also renting a tea shop on the main building's first floor. Operational plans include the following:

A. Proposal for the Park's Operations

In accordance with the Contractual Agreement signed with the Taipei City Government, the Foundation was required to prepare a proposal for the Park's operations in three months' time, including management design, organization, and implementation, ticket sales systems, visitor circulation throughout the Park, cost estimates for Park management, Park management terms and conditions, notices for visitors, site usage terms and conditions, Park websites, etc. The Foundation submitted the first draft of its proposal on December 31, 2020, and revised versions on February 26 and April 16, 2021. In addition, regular meetings with staff from the Taipei City Government Department of Cultural Affairs and other Taipei City Government agencies were held on a monthly basis.

B. Training Volunteers

In June 2020, the Foundation launched efforts to recruit volunteers to serve at the Park. A total of 124 applications were submitted, of which 102 were accepted. A training program was subsequently enacted from March to April 2021, including classes on visitor circulation throughout the Park, guided tours of the Chi-Hai Residence, etc. There was also a day-long lecture series on March 26, featuring talks by Chairman Fredrick F. Chien, President Yun-han Chu, Board Member James C. Y. Soong, and Professor Tai-chun Kuo. An evaluation of the volunteers was conducted on April 12-17.

C. Property Management

In order to ensure the smooth management of the Park's operations, it proved necessary to hire a property management company to take care of matters such as visitor care, cleaning, security, electrical and mechanical work, etc. After an extensive search, the Foundation decided to hire Yellowstone Service Co., Ltd., which commenced work at the Park in May 2021.

In terms of ticket purchases, dining, and parking at the site, since the Park only occupies a small area and large crowds of people are expected to visit, after consultations with the Taipei City Government, the Foundation decided that, during the three months following the Park's Opening Ceremonies, visitors would have to book tickets online in advance. Discussions are currently underway as to whether such a policy would be enacted for a longer period of time.

D. Fund-raising

Chairman Fredrick F. Chien and President Yun-han Chu have devoted unstinting efforts towards raising the funds needed to complete this project. Fortunately, Ruentex Group Chairman Samuel Yin pledged to make an in-kind

donation of NT\$248,786,437 consisting of four payments, with NT\$213,285,161 donated as of late May 2021. In addition, the Joe and Clara Tsai Foundation founded by Dr. Joseph Chung-hsin Tsai donated US\$6,800,000. Other recent donations totaled NT\$20,000,000. The fund-raising goal for this project was NT\$1,030,000,000, with a total of NT\$1,000,000,000 (97% of intended target) raised by May 2021. As a token of its eternal gratitude, the Foundation is preparing electronic honor roll displaying the names and photographs of leading donors.

(5) Project to Interview the Children of Former President Chiang's Cabinet Members

In the past, the Foundation cooperated with Professor Chang Li, Research Fellow at the Institute of Modern History, Academia Sinica, to carry out a project for interviewing members of Former President Chiang's staff. Now a new project is being launched, which featured interviews with the daughter of Former Premier Yun-suan Sun, as well as other children of former Cabinet members starting in November 2020. These materials will be placed in the Presidential Library, and can also be used in future exhibitions.

(6) Maintenance of the Chi-Hai Residence and its Artifacts

Following the completion of restoration work on the Chi-Hai Residence in 2014, the Foundation took charge of the daily maintenance of this treasured historic site, including its interior, storage rooms, parking garage, and

guardhouse, as well as the grounds and equipment. More recently, the Foundation has been working to prepare over 70 items from the Residence to be displayed in the Presidential Library's exhibition halls as well as the Residence's Anteroom, including documents, photographs and other historical artifacts.

As of late April, 2021, the Residence's online database contained 66,839 items, while ongoing efforts are being made to collect, purchase or accept donations of additional artifacts. These include works written in Chinese or foreign languages, which will be shelved as part of the Library's collection. Plans are also being made for online resources and a library automation system to be included in the Library's Reference Room.

(7) Flag-Raising Ceremony to Honor 112th Anniversary of the Birth of Former President Chiang Ching-kuo

April 27, 2021 marked the 112th anniversary of the birth of Former President Chiang Ching-kuo. In order to honor this significant occasion, Foundation President Yun-han Chu led the Foundation staff to take part in a flag-raising ceremony at the Chi-Hai Residence. Honored guests included Chairman Samuel Yin and other members of the Ruentex Group, Chiang Ching-kuo's eldest grandson Chiang Yo-song, etc. The ceremony was solemn but deeply moving, particularly the sight of the national flag fluttering over the site after a 33-year gap. In addition, President

Chu presented Chairman Yin with a reproduction of Yu Youren's calligraphy and a certificate of gratitude to express the Foundation's heartfelt appreciation for the donations and other assistance provided. Following the ceremony, Foundation staff members took the guests on a guided tour of the Library's exhibition halls.

(8) Plans for the Opening Ceremony of the Ching-kuo Chi-Hai Cultural Park and Chiang Ching-kuo Presidential Library

The Opening Ceremony of the Ching-kuo Chi-Hai Cultural Park and Chiang Ching-kuo Presidential Library was originally scheduled to be held at 10 a.m. on May 31, 2021, with distinguished guests including ROC President Tsai Ing-wen, Former President Ma Ying-jeou, Taipei City Mayor Ko Wen-je, Former Mayor Hau Lung-pin, Chiang Ching-kuo's eldest grandson Chiang Yo-song and other Chiang family members, Board of Directors Members and Supervisory Board Members, donors, social elites, members of the diplomatic corps, and other dignitaries. Secretary General to the President David Tawei Lee also visited the site on May 14, providing valuable guidance and advice.

Unfortunately, however, on May 11, the Central Epidemic Command Center raised the COVID-19 alert to Level 2, thereby prohibiting outdoor gatherings of over 500 people and indoor gatherings of more than 100 people. In

order to adhere to government policy, the date of the Opening Ceremony had to be postponed, with all guests being notified of this change of plans. The Taipei City Government agreed in principle to permit the Ceremony's staging and Park's opening within two months after this public health crisis had been successfully resolved.

2. Visits to the Foundation and Pursuit of International Scholarly Exchange

(1) Singapore Trade Office in Taipei Deputy Trade Representative Mr. Philip Ong Visited the Foundation

On October 28, 2020, Singapore Trade Office in Taipei Deputy Trade Representative Mr. Philip Ong visited the Foundation, and held discussions with President Yun-han Chu regarding recent academic developments in Taiwan and Singapore. President Chu had served on the Singapore Ministry of Education's Social Sciences Review Committee from 2002 to 2008, and had words of praise for the government's investments in higher education, particularly recruiting senior scholars from throughout the world to serve as chair professors. Such efforts have proven invaluable for Singapore's academic development, and can serve as an inspiration for Taiwan's own government.

(2) Meeting with Moscow-Taipei Coordination Commission on Economic and Cultural Cooperation Representative Sergey Petrov

On November 12, 2020, Moscow-Taipei Coordination Commission on Economic and Cultural Cooperation (MTC) Representative Sergey Petrov invited President Yun-han Chu for a meal and to discuss academic developments in Russia and Taiwan. President Chu explained in detail the Foundation's long-term and fruitful relationship with Institute of Oriental Manuscripts at the Russian Academy of Sciences, with both men expressing their hope for further activities in the realm of international scholarly exchange in the future. Representative Petrov also presented President Chu with a copy of Mark O'Neill's recent book *China's Russian Princess: The Silent Wife of Chiang Ching-kuo*, which was published in March 2020 and treats the legendary life of Former President Chiang's Russian wife Faina Chiang Fang-liang. President Chu then explained the Foundation's work in constructing the Chiang Ching-kuo Presidential Library, noting that this book would be a valuable addition to its collection and future exhibitions.

(3) India Taipei Association Director General Gourangalal Das Visited the Foundation

On November 12, 2020, India Taipei Association Director General Gourangalal Das and Deputy Director General Sohag Sen visited the Foundation, where they were received by President Yun-han Chu. President Chu explained to them the Foundation's mission of promoting international scholarly exchange in the field of Chinese Studies, including interaction between academic organizations. He also made special mention of the

Foundation's Developing Regions program, which represents its commitment towards supporting new Chinese Studies programs in regions that have only recently launched such undertakings, including countries in Eastern and Central Europe, Southeast Asia, South Asia, the Middle East, and Central Asia.

(4) Global Public Diplomacy Network Online Roundtable

At the behest of the "Exchange of Knowledge Project" organized by the Global Public Diplomacy Network (GPDNet), an online roundtable entitled "The Power of Public Diplomacy" was held in the Foundation's conference room on September 1, 2020. The roundtable was presided over by Foundation Vice-President Chun-i Chen, with invited speakers including Professor Chen-shen Yen (National Chengchi University; "Public Diplomacy for a Pariah State") and Professor Chao-chen Lin (National Taiwan University; "Mobile Reporting: Promoting Democracy or Spreading Fake News?"). The two discussants were GPDNet Secretary General Darwish S. Ahmed Al Shebani and *The Philippine Daily Inquirer* Senior Editor Joselito B. Zulueta. In addition, the following GPDNet member organizations were invited to join this event: National Commission for Culture and the Arts (Philippines), Katara Cultural Village Foundation (Qatar), while GPDNet members of the following organizations and related NGOs also took part in the roundtable: Singapore International Foundation (Singapore), Yunus Emre Institute (Turkey), National Department for Culture and Arts (Malaysia), Korea Foundation (Korea). All of the participants engaged in a lively discussion.

IV. Other Activities and Events

1. Emeritus Board Member Ying-shih Yu Has Passed Away

The global scholarly community mourns the loss of Emeritus Board Member Ying-shih Yu, who passed away in his sleep at his Princeton home on August 1, 2021.

Professor Yu was an esteemed scholar and venerable public intellectual hailed as the greatest Chinese historian of his generation, a master of both political and cultural history whose knowledge spanned the centuries and encompassed both Chinese and Western cultural traditions. In honor of his tireless lifetime contributions in the humanities, Professor Yu was awarded the Kluge Prize in 2006, an achievement representing the equivalent of being recognized as a Nobel Laureate in the humanities and social sciences. Professor Yu's accomplishments were also recognized by his being granted the inaugural Tang Prize in Sinology in 2014 for his mastery and insight into the wide range of Chinese historical traditions.

In addition to his momentous record of scholarship, Professor Yu devoted himself to cultivating and supporting the next generation of scholars, while his profound concern for social justice and human rights earned admiration worldwide. Taiwan's gradual development into a leading force in Chinese Studies throughout the globe could not have been achieved without Professor Yu's dedicated endeavors.

In 1986, three of Academia Sinica's leading Academicians, Cho-yun Hsu, Ying-shih Yu, and Kwang-chih Chang sent a letter to the Presidential Office of the Republic of China recommending the establishment of the Foundation as an independent non-governmental scholarly agency. Inspired by similar examples in the West, Japan, and Korea, they embraced a vision of the Foundation's mission as one of promoting international scholarly exchange while abiding by established academic principles and enhancing Taiwan's prominence in the global scholarly community. Their efforts earned the support of leading government officials, including Premier Kuo-hwa Yu as well as Minister of Education Huan Lee, who helped transform their vision into a reality, with all three of these scholars serving as the Foundation's inaugural Board Members.

Ying-shih Yu was not only one of the Foundation's founders, he also proved to be a pillar of support and a faithful guardian. During the past 30 years, the Foundation has earned a sterling reputation worldwide for its unstinting promotion of Chinese Studies and international scholarly exchange. Through good times and bad, and sometimes in the face of external pressures, Professor Yu proved steadfast in his commitment to helping the Foundation overcome the challenges it faced and develop into the global academic force it has become today. All Foundation colleagues are deeply grieved to learn of the passing of this eminent intellectual.

2. Emeritus Board Member Cho-yun Hsu Honored with Lifetime Achievement Award

On November 28, 2020, Emeritus Board Member Cho-yun Hsu was honored with the bestowal of a Lifetime Achievement Award at the Fourth Global Chinese Studies Ceremony. This prestigious event, held by the Hunan University Yuelu Academy, Phoenix Media, and Dunhe Foundation since 2014, recognizes outstanding achievements by senior scholars whose work has shaped the field of Chinese Studies.

During remarks of gratitude, Emeritus Board Member Hsu noted that during the past millennia, Chinese culture has faced countless challenges yet has always been able to adapt, which represents a truly remarkable feat of human history. He also called on people in today's cultural fields to engage in further discussions of how Chinese culture can best adapt to the current challenges it faces, while also enhancing their own efforts to make contributions towards the future.

Emeritus Board Member Hsu, who is also an Academia Sinica Academician and Professor Emeritus at the University of Pittsburgh, has devoted his distinguished career to the study of Chinese cultural history, and has earned worldwide renown for his stimulating research results. In addition, he has consistently helped the Foundation in promoting international scholarly exchange. The Foundation is deeply proud of his exceptional achievements having been recognized in the form of this great honor.

3. Distinguished Research Fellow Siao-chen Hu Appointed to Serve as Foundation Vice-President

With the opening of the Chiang Ching-kuo Presidential Library fast approaching, the Foundation's workload has continued to increase. Therefore, it was decided to ask Professor Siao-chen Hu, Distinguished Research Fellow at the Institute of Chinese Literature and Philosophy, Academia Sinica, to serve as Vice-President and the Library's Curator, effective April 1, 2021. Born in 1964, Vice-President Hu holds a B.A. in Foreign Languages and Literature from National Taiwan University, an M.A. in Literature from the University of California, San Diego, and a Ph.D. from the Department of East Asian Languages and Civilizations at Harvard University. She has published numerous books and articles in Chinese and English treating late imperial and modern Chinese culture.

4. Chairman Fredrick F. Chien Invited to Give a Lecture at the China Youth Corps

On the morning of April 27, 2021, the 112th anniversary of the birth of Former President Chiang Ching-kuo, Chairman Fredrick F. Chien was invited to give a lecture entitled "Following in the Footsteps of President Chiang Ching-kuo" at the headquarters of the China Youth Corps. Over 100 people attended this event, and were touched by Chairman Chien's moving account of his experiences with Former President Chiang during his long years of service.

On October 31, 1952, Chiang Chiang-kuo presided over the ceremony marking the formation of the China Youth Corps. Chiang Kai-shek was its Commander, while Chiang Ching-kuo served as Director, dedicating himself to that post for a total of 21 years. Chairman Chien's lecture marking the 112th anniversary of the birth of Former President Chiang Ching-kuo thus proved to be an occasion of special significance.

FINANCIAL STATEMENT

Jan.1, 2020-Dec.31, 2020

Since the outbreak of the Covid-19 pandemic in early 2020, governments around the world have implemented social distancing measures to contain the coronavirus. Global economic activities and financial markets had been severely impacted by the pandemic, and loose monetary policies and massive fiscal stimuli have been adopted to alleviate the impact.

Due to the uncertainty of the pandemic and vaccination against Covid-19, the Foundation conservatively reduced its allocation to risk assets and increased its allocation to bond and money market funds. The stock market crash in March 2020 and bounce-back rallies thereafter made the year one of the most volatile in history. The Foundation did not respond well in the early stage of the crisis and missed the opportunity to fully recover its losses.

By the end of 2020, the total assets of the Foundation were US\$153,548,451, including US\$127,467,354 in current assets, US\$3,577,868 in fixed assets, US\$22,500,420 in intangible assets, and US\$2,809 in other assets (see Balance Sheet).




